Eligibility Criteria

- Nominees must be members of CAR in good standing.
- The award is intended to recognize individual contributions, association and/or company-wide efforts.
- The nominee's community work must have been conducted, started or completed between November 1, 2009 and August 1, 2010.
- Nominees should be able to document the results of their involvement through published reports and/or testimonials from the organization they served.

Scoring/Judging

- All entries will be evaluated by an independent panel of judges appointed by the Chair of the CAR Communications Committee.
- Donations will be made on the recipients behalf to the community service organization named on the entry form in the amount of \$1,000.
- Information provided on the application is subject to verification.

Instructions

- Members may nominate themselves.
- Nominations must include a signed entry form.
- All entries must be typed.
- Attach additional pages as needed.
- Send one copy of your entry and backup documentation.
- Entries become the property of CAR and will not be returned.
- Incomplete entries or those that do not conform to the guidelines will be disqualified.
- No entries will be accepted past the Friday, August 27, 2010 deadline.
