Scott's Hot Topic

Earnest Money Disputes

Year in and year out, questions about earnest money comprise the common Hotline calls that we receive. Regardless of the market conditions, REALTORS commonly face the reality that their client(s) they are entitled to the Earnest Money deposit. Sometimes there is a dispute between the buyer and seller regarding the Earnest Money. case, the parties will either resolve the dispute through mediation other or they will get an answer to their question...from a judge.

More commonly, Earnest Money disputes reflect ONE PARTY (either the buyer or the seller) who is simply being difficult and intransigent on their position. They KNOW they should sign a release but are simply unwilling to do so. In that case, I commonly encourage REALTORS to point out Paragraph 4.3.2.1 (Seller) or Paragraph 4.3.2.2 (Buyer) of the Commission-approved Contract to Buy/Sell Real Estate. In the case of a merely "difficult" party, those paragraphs add some consequence to the discussion for an individual's unwillingness to "do the right thing" and execute an Earnest Money Release for the benefit of the other party. In the event they don't, those provisions could support additional damages against the "difficult" party for their failure to cooperate.
